Chairman Randazzo:

We have recently been made aware of a video circulating (see link: <https://www.youtube.com/watch?v=4p7VFVQ7Nw&feature=youtu.be&app=desktop>), which depicts a woman being removed from a public meeting regarding a pending wind farm proposal in Erie and Huron counties. The video alleges that the woman had not acted disruptively, and was removed simply because of her opposition to the project. After reviewing the video ourselves, we join our House colleagues in deep concern that the public has not been given a fair opportunity to express opposing viewpoints, and that the “public meetings” are being treated as little more than a formality by the wind project’s developers.

All members of the public should have the opportunity to attend, listen, and be heard. For this reason, we would respectfully request that no further actions in the process of the approval of this project be taken by the Public Utilities Commission of Ohio, until a full investigation of this incident has been conducted. If the allegations purported in the video are true, then we would further request that the developers of the project be required to hold another public meeting, in which *all* members of the general public are permitted to attend and speak out, whether they support or oppose the development.
